NEW COMBINED ACT/WORKKEYS ASSESSMENTS INDICATOR

Senate Bill 335 has become Session Law 2018-97. According to the technical corrections under this new session law, for the 2017–18 school year, the ACT and WorkKeys indicators are now combined to calculate School Performance Grades (SPG), and the combined measure is considered one of the School Quality or Student Success indicators under ESSA. Additionally, for reporting purposes in the School Report Card (G.S. 115C-12(9)c1), performance shall be reported on combined indicator and separately on ACT performance and WorkKeys performance.

The combined ACT/WorkKeys indicator for SPGs and reporting uses grade 12. Reporting on the separate ACT performance uses the grade 11 (current year) results. Reporting on the separate WorkKeys performance uses CTE Concentrators in grade 12.
